

## Drexel Heritage Online Sweepstakes Official Rules

---

**No Purchase Necessary. Void Where Prohibited.  
Open to Legal Residents of the United States,  
18 Years of Age or Older as of July 14, 2008.**

1. **Sweepstakes Timing:** Sweepstakes begins at 12:00 a.m. EDT on July 14, 2008 and ends at 11:59 p.m. EDT on September 14, 2008 (“Sweepstakes Period”).
2. **How to Enter:** To enter the Drexel Heritage Online Sweepstakes (“Sweepstakes”), visit [www.drexelheritage.com](http://www.drexelheritage.com) and click on the Sweepstakes link to register for an entry (“Entry”) into the Sweepstakes. Normal Internet access and usage charges imposed by your online service will apply. Entries must be received by 11:59 p.m. EDT on September 14, 2008 to be eligible for the Grand Prize Drawing. Limit one entry per person/email address, per day. Entries must be complete to be eligible.
